

Symposia Abstracts

Session 1 - Gastrointestinal (GI) services in the 21st century

Early detection of liver disease

Professor John Dillon, *Professor of Hepatology and Gastroenterology, University of Dundee*

Mortality from chronic liver disease (CLD) in the UK has increased by over 400% since 1970, driven by alcohol, non-alcoholic fatty liver disease (NAFLD) and hepatitis C virus (HCV), the natural histories of which can all be improved by early intervention. Patients often present with advanced disease, which would be preventable if diagnosed earlier and lifestyle-change opportunities offered.

Liver function tests (LFTs) are very commonly measured. Approximately 20% are abnormal, yet the majority are not investigated at all. Less than 20% are investigated according to guidelines but investigating all abnormal LFTs to identify early liver disease would overwhelm services. Recently, several diagnostic pathways have been launched across the country; some focus on abnormal LFTs and some on assessing at-risk populations.

This review will collate the evidence on the size of the problem and the challenge it poses. We will discuss the limitations and restrictions within systems that limit the responses available. We will review the current pathways being evaluated and piloted in the UK and explore the arguments for and against LFT-based approaches and 'case-finding strategies' in the community diagnosis of liver disease.

Furthermore, the role of fibrosis assessment methods (including scoring systems such as FIB-4 index, the Enhanced Liver Fibrosis (ELF) test, and elastography) within these pathways will also be discussed.

Session 2 - Providing quality GI services

Cytosponge: integrating a non-invasive test for Barrett's oesophagus into clinical care

The endoscopy service was placed under unrecoverable pressure during the COVID-19 pandemic and alternative methods of Barrett's detection and surveillance were introduced. This talk describes the Scottish experience of Cytosponge for assessment of reflux patients and surveillance of Barrett's oesophagus and the effect on the endoscopic practice.

Session 3 - Transition services in gastroenterology

Transition services in gastroenterology – multidisciplinary panel presentations & discussion

IBD

Dr Philip Smith, *Liverpool University Hospitals NHS Foundation Trust*

This session will provide an introduction to gastroenterology and hepatology transition from paediatric to adult care, and touch on the long-term impact of failure or absence of transitional care. We will demonstrate how transitional services can be set up, utilising the 2017 guidelines by the British Society of Gastroenterology.¹

In addition, we will provide real-world case presentations involving transition patients and provide discussion around this, focusing particularly on the psychosocial needs of patients, and the importance of the transition 'key worker' healthcare professional in the process. Transition is not just confined to luminal patients and so we discuss the transition of hepatology patients, including liver transplant patients. Finally, we provide a patient's view of transition delivered by a patient who has successfully transitioned through our service. Questions are invited during the session to aid interaction with delegates.

Session 4 - Anaemia

Video capsule enteroscopy (VCE) in patients with anaemia

Small-bowel capsule endoscopy (SBCE) is considered the first-line test for small bowel investigation of recurrent or refractory iron-deficiency anaemia and this is supported by national and international guidelines. ^{1,2} It is a non-invasive, patient friendly, safe procedure which is highly sensitive in identifying small bowel abnormalities. Commonly identified

pathology include vascular lesions, inflammation and occasionally small-bowel tumours. The yield of SBCE is increased by increasing age, co-morbidity and transfusion dependency. SBCE alters management, since identified abnormalities may be amenable to treatment by device assisted enteroscopy, medication or surgery. Capsule endoscopes to image the upper gastrointestinal tract and colon are now available and may offer a more patient friendly, non-invasive means of examining the stomach and colon.
